1. Call to Order and Chair's opening remarks Called to order at 9:00 a.m.

2. Approval of Minutes of November 10, 2011

3. Minister Griffiths, Alberta Municipal Affairs

Recently appointed Minister of Municipal Affairs, the Honourable Doug Griffiths attended the meeting to greet the members of the Capital Region Board. He commended the CRB members on their collaborative work and progress achieved with the Growth Plan and other projects. The Ministry considers CRB funding part of their mandate going forward and the Government will continue to support the Board and its activities into the future.

6. Governances Issues

a. Appointment of CRB Auditor (2012-2014)

Mayor Crouse provided an overview of the recommendation approved by the Governance meeting on November 21, 2011. It was noted that the recommended company, Hawkings Epp Dumont, met the qualifications required to provide the audit services and their estimated costs were less than that of other proposals received.

At the request of Mayor Shaigec, the votes were recorded for all motions at this meeting.

b. Budget 2012

Mayor Crouse provided an overview of the amended Budget 2012, as recommended by Governance. It was noted that the amendments to this Budget included funds to cover the costs for a new CRB Chair and CRB administration expenses to cover additional resources required. A note was added to the Budget to specify Other Income to be "Subject to available funding".

It was requested that additional funding for the Transit Committee, Transit Executive Position be amended to state Transit technical support. CRB Administration noted that they will change the wording in the contract to acquire this support.

f. Election of CRB Chair

Mayor Crouse provided an overview of the recommendation and rationale to amend the selection process for the election of a Chair of the Board, as approved at the recent Governance Committee.

Members discussed the proposed selection process in comparison to the previous option approved by the Board (November 10, 2011), included in Policy # G010, for the selection of Chair & Vice Chair/Interim Chair & Vice Interim Chair.

Motion: That the Capital Region Board approves the amended selection process for the election of Chair, as approved by the Governance Committee at their meeting on November 21, 2011.

d. Funding for the Transit Executive in the 2013 and 2014 Business Plan Mayor Crouse gave a brief overview of the recommendation from the Transit Committee to fund the Transit Executive position.

It was noted the planning for the role for a Transit Executive will ensure continuation of strategic senior technical transit advisory services.

Motion: The Capital Region Board approves the addition of \$100,000 in 2013 and \$100,000 in 2014 in the 3 year CRB Business Plan to fund the Transit Executive position.

7. Minister Danyluk, Alberta Transportation (II:00 a.m. – Noon, lunch served @ 11:30 a.m.)

The recently appointed Minister of Transportation, Honourable Ray Danyluk attended the meeting and made a presentation to the Board on the current and future initiatives planned for Alberta Transportation. He highlighted and congratulated the Board on their recent work including GreenTRIP, the Integrated Regional Transportation System Study (IRTSS), the 30 Year Transit Service Plan, and the Integrated Regional Transportation Master Plan (IRTMP) and expressed the need for and willingness of Alberta Transportation to work with municipalities on current and future issues. It was noted that Alberta Transportation has recently received copies of the IRTSS, IRTMP, and the 30 Year Transit Service plan that were provided to Minister Griffiths for approval. The government will begin the process of reviewing the plans and hopes to respond to the CRB in the near future. The Minister asked the Board to reconfirm their support for the IRTSS, IRTMP and 30 Year Service Plan. He again congratulated the



Board on their achievements and cooperation and noted that Alberta Transportation will continue to support the CRB.

Councillor Iveson replaced Mayor Mandel as the City of Edmonton's representative.

e. 2012-2014 Capital Region Board Business Plan

Mayor Crouse provided an overview of the amended 2012-2014 Business Plan that includes the addition of \$100,000 for the Transit Executive in 2013 and 2014, funding associated with an elected chair and CRB administration costs and the inclusion of the Pipeline Linkages Strategy Committee. The CRB Business Plan will provide direction to CRB Administration to plan the operations of the Board and ensure that sufficient staff and resources are in place to carry out the Board's Regulatory requirements and other activities. The Plan will be submitted to the Province upon approval as part of the conditional Grant agreement between the CRB and Alberta Municipal Affairs. It was noted that activities will only be undertaken as resources are available to implement the Business Plan.

Amended Motion: That the Capital Region Board approves the amended 2012-2014 Business Plan as endorsed by the Governance Committee on November 21, 2011, subject to a review on an annual basis of the Board's activities and budget. Activities will only be undertaken as resources are available to implement the Business Plan.
